

#### सशस्त्र सीमा बल की वन्य जीव अपराधों की रोकथाम में भूमिका

है। नेपाल व भूटान हमारे मित्र राष्ट्र हैं और संवेदनशील हो जाते है। इनके साथ लगने वाली सीमाएँ खुली हैं। इसके कारण से सीमाएँ तस्करों के लिए अनुकूल रही व उत्पादों, अवैध हथियारों एवं जाली नोटों की सम्पदा व वन्य जीवों को रक्षा कवच प्रदान तस्करी होती है। सीमा सुरक्षा की दृष्टि से इन किया है। बल के सतर्क जवानों ने इन क्षेत्रों से अपराधों को रोकना सशस्त्र सीमा बल के लिए संपदा और जीवों की होने वाली तस्करी एवं चुनौती पूर्ण रहता है।

SSB has been a key partner of WCCB in its endeavor in fighting the illegal wildlife trade. Several wildlife operations & training programmes have been conducted by joint team of WCCB and SSB in the past years across the Indo-Nepal Border. A glimpse of the joint wildlife operations and training programmes undertaken by WCCB in partnership with SSB.











#### **Joint Wildlife Operations**

A Leopard-Skin was seized from Samuktola, West Bengal on 30.01.2020, in a joint operation of WCCB, SSB and W.B Forest Department.; On 17.08.2020, three Deer Antlers were seized from 03 accused by joint team of WCCB, Jaldapara Wildlife Division and 17 BN SSB near Rangali bazna. On 01.10.2020, WCCB & 8th BN SSB, conducted a joint operation and arrested one accused and seized one leopard skin at Naxalbari.; On 30.01.2020, a joint operation was conducted by SSB, WCCB and W.B Forest Dept. resulting in seizure of 01 Leopard skin and arrest of one accused.; On 06.09.2020, joint team of WCCB, Police, Forest Dept., and SSB, arrested three accused and seized 02 Elephant tusks, 01 Deer antler with skull, 01 Hand made gun (Gazimara), 26 Ammunition, 06 Crackers, from Baksa, BTAD Assam.; On 28.09.2020, joint team of WCCB and officials of Binnaguri Forest Range, W.B & 17 BN SSB Falakata, arrested two accused and seized 05 live Tockay Geckos.; On 20.10.2020. SSB team posted at Tentulberia, South Bengal Frontier seized 54 Lorikeet birds of 06 rare varieties and WCCB provided assistance in identification and immediate care to the birds and handing them over to Alipore Zoo, Kolkata. On 02.11.2020, one deer skull was seized from a suspect at Bagdogra, Siliguri by join team of WCCB and SSB.; On 12.11.2020 joint team of WCCB, SSB & Assam Forest Dept. seized 04 Elephant tusks and arrested two persons near Koila-Moila range under Chirang Forest Division, Assam.; On 20.11.2020, on intillegence of WCCB, a joint wildlife operation was conducted by 34th BN SSB Alipurduar & W.B Forest Directorate near Chilkana in which 01 live pangolin was rescued and 01 person was arrested.; On 12-01-2021, on Intelligence of WCCB, 15th BN SSB seized a live Pangolin and apprehended 04 persons from Kanjalgaon area of Assam.; On 09.02.2021, joint team of WCCB and 8th BN SSB seized one Deer antler from one accused near Atal market.; 05 Kg. of Pangolin scales were seized and two persons were arrested by joint team of WCCB, SSB and Assam Forest Dept., on 17.04.2021 at Khanapara, Guwahati.; On 20.07.2021, joint team of WCCB and 41 BN SSB Ranidanga, seized of 2.12 kgs. of Pangolin scales and arrested three persons, at Bagdogra, Siliguri







#### **Sensitization Programmes**

**Delhi** Joint team of WCCB and Delhi Forest Dept. seized 17 canines and 11 claw of big cat species and arrested one person from Delhi, on 02-07-2021.

**Madhya Pradesh:** On 02-07-2021, joint team of WCCB and M.P Forest Dept. seized Indian soft shell Turtles and arrested three persons from M.P.

**Andhra Pradesh:** 08 Kg. of Ambergris (Sperm Whale's Vomit) was seized and 08 persons were arrested by joint team of WCCB and Andhra Pradesh Police from Guntur, on 02-07-2021.

**West Bengal:** One live Malabar Hornbill was seized by joint team of WCCB and Barasat Forest Range Office from the possession of two persons on 06-07-2021, at Bhabanipur.

**Kerala:** Joint team of WCCB and Kerala Forest Dept., seized 19 kg. of Ambergris (Sperm Whale vomit) and arrested 03 persons from Thrissur, Kerala, on 09-07-2021.

**Nepal:** On intelligence of WCCB, a Leopard-skin and a Pangolin-skin along-with scales, were seized & 02 wildlife traffickers were arrested by CIB, Nepal, on 09-07-2021 at Kathmandu.

**Maharashtra:** 720 pieces of Paint brushes, made out of Mongoose hairs, were seized by joint team of WCCB and Pune Forest Division from Pune, on 10-07-2021.

**Odisha:** 08 Leopard-skins, 02 Tiger-claws, 01 Leopard-canine, and a fake Tiger-skin were seized & 07 persons were arrested by joint team of WCCB along-with Chhattisgarh & Odisha Forest Dept. team, in an operation conducted on 09/10-07-2021 at Kalahandi.

**West Bengal:** Joint team of WCCB and Kolkata Police seized 3.11 kg. of Pangolin-scales & 38 Pangolin-claws from the possession of two persons at Kolkata, on 11-07-2021.

**Maharashtra:** 10 Tiger/Leopard claws were seized and three persons were arrested by joint team of WCCB, Buldhana & Melghat Tiger Reserves, from Nandura, on 13-07-2021.





















**Uttar Pradesh:** Joint team of WCCB & U.P. Forest Dept. seized 02 Indian Flapshell Turtles with 20 Claws & arrested 03 persons from Saharanpur, on 15-07-2021.

**Andhra Pradesh:** Joint team of WCCB and Andhra Pradesh Forest Dept. seized three Red Sand Boa snakes and arrested 04 persons from Guntur, on 16-07-2021.

**Assam:** 12 kg. of dry Pangolin-scales & 15 Tokay Geckos (13 live & 02 dry), were seized and two persons were arrested by joint team of WCCB and Assam State Forest and Police Dept. from Bokajan, on 18-07-2021.

**Odisha:** On an intelligence of WCCB, one Leopard skin was seized and four persons were arrested by Deogarh Forest Division, Odisha, on 19-07-2021.

**West Bengal:** 02 kg. of dry Pangolin scales were seized & 03 persons were arrested in a joint operation of WCCB and 41st BN SSB, Ranidanga, on 20-07-2021.

**Himachal Pradesh:** Joint team of WCCB and H.P Police seized 02 Leopard skins along with 14 claws and 12 canines from Mandi, on 20-07-2021.

**West Bengal:** 02 Indian Star Tortoises were seized by WCCB team from a person at Kalighat area of Kolkata, on 22-07-2021.

**Odisha:** 15.2 kg. of Pangolin scales were seized and 02 persons were arrested by joint team of WCCB and Odisha Forest Dept., on 24-07-2021 at Dhenkanal.

**Uttar Pradesh:** Joint team of WCCB and U.P. Forest Dept. seized 04 Common Sand Boa Snakes, 02 Red Sand Boa Snakes & 02 Indian Rat Snakes and arrested one wildlife trafficker from Lucknow, on 27-07-2021.

**Assam:** 5.8 kg. of dry Pangolin scales were seized by joint team of WCCB and Assam Forest Dept. at Lumding market, Assam, on 03-08-2021.

**Bihar:** Joint team of WCCB & Purnia Forest Division seized a large elephant tusk ivory piece (approx. 16 kg.) and arrested 05 persons from Purnia, Bihar, on 05-08-2021.













**Uttar Pradesh:** Joint team of WCCB and U.P State Police & Forest Departments seized 265 gms. of Pangolin scales and arrested one person from Ghaziabad (U.P), in the intervening night 07 & 08 Aug, 2021.

**Tamil Nadu:** Joint team of WCCB and TNFD seized 05 Turtle carapaces, 10 Sea Shells, 01 Sea Fan, 05 Elephant-ivory-statues, 17 Elephant-ivory articles, 01 porcupine-quilt-made box, 01 pair of Spotted-Deer horns & 02 Sea Horses, at Kanniyakumari, on 07-08-2021.

**Karnataka:** On intelligence inputs of WCCB, Karnataka Police and Forest Dept. seized ivory artifacts including Elephant-Ivory articles, Deer Antlers, Porcupine quills, Sea horses, Tiger claws, Coral, and exotic animal pelts, on 08-08-2021.

**Uttar Pradesh:** on 11-08-2021, 193 Parakeets (159 Rose -Ringed & 34 Alexandrine) were seized and a person was arrested by joint team of WCCB & U.P Forest Dept. from Nazibabad,

**Rajasthan:** On intelligence of WCCB, 25 Alexandrine Parakeets were seized and 02 persons were arrested by Rajasthan Forest Dept. from Jaipur, on 12-08-2021.

West Bengal: On input regarding illegal possession of an antler by a passenger, WCCB seized a pair of Deer Antler with skull, at Kolkata Airport, on 15-08-2021.

**Tamil Nadu:** 76 Rose-ringed Parakeets were seized by joint team of WCCB & TNFD at Salem, on 16-08-2021.

**Maharashtra:** Joint team of WCCB and Maharashtra Forest Dept. seized 11 Tiger/Leopard claws and arrested 02 persons from Karad, Satara District of Maharashtra, on 16-08-2021.

**Tamil Nadu:** 2247 live Star Tortoises, packed in pillow covers along-with few crabs were seized by joint team of WCCB & Customs Cargo Intelligence Unit from a cargo destined to Bangkok, on 16-08-2021.











**Maharashtra:** A joint raid of WCCB & Maharashtra Forest Dept., led to seizure of 160 pieces of Black Corals and arrest of one person from Pune, on 18-08-2021.

**Tamil Nadu:** Joint team of WCCB & T.N Forest Dept. conducted raids and seized 36 Kg. of Ambergris and arrested 13 persons, on 19-08-2021, at Chennai.

Madhya Pradesh/Maharashtra: On 24-08-2021, over 05 kg. of Tiger bones were seized and one person was arrested by joint team of WCCB and M.P State Forest & Police Dept. from Khawasa (M.P). On revelation of the accused, Deer Antlers, Bones, two guns were seized and two more persons were arrested from Maharashtra

**Assam:** On intelligence of WCCB, three persons were arrested with Rhinoceros horn by joint team of Morigaon Police and 2nd AFPF Seconi, on 26-08-2021.

**West Bengal:** 658 live Parakeets were seized and 04 persons were arrested by joint team of WCCB and CID, West Bengal from Durgapur, on 26-08-2021.

**Gujarat:** 780 pieces of Black Corals including 82 framed pieces, were seized by joint team of WCCB and Vadodara Forest Dept. from Vadodara, on 26-08-2021.

**Jharkhand:** On intelligence of WCCB, 250 Parakeets were seized and 02 persons were arrested by RPF, Barahawa, in the intervening night of 2 & 3 Sept, 2021.

**Maharashtra:** Joint team of WCCB and Maharashtra Forest Dept. seized a piece of Walrus tusk and arrested 03 persons at Sawantwadi, Maharashtra, on 31-08-2021.

# A big seizure of assorted wildlife contrabands



A significant operation was conducted by joint team of WCCB and Himachal Pradesh Police on 25th Aug, 2021, in which a huge catch of assorted wildlife contraband was seized and 03 wildlife traffickers were arrested from Nalagarh (H.P). Seized items included 21 Live Snakes (Indian Cobra, Rat Snake, Common Krait & Wolf Snake), 02 Carcasses (Indian Cobra), 12 Hatha Jodi (Monitor Lizard Genital Organs), 24 Siyar Singhi, 06 Big Cat Claws, 11 Monitor Lizard Paws, 02 Sambar Deer Antler, 02 Alexandrine Parakeets, 05 Pangolin Claws, along-with some unidentified bones and claws. The team also seized 01 Air Gun, 04 Leg Hold Traps, 04 Snare Traps, and 02 Nets used for capturing small mammals & birds from the accused.













**Uttar Pradesh:** A joint operation of WCCB and U.P State STF & Forest Dept., led to arrest of two persons while they were trying to sell Hyena bones at Varanasi, on 03-09-2021.

**Uttar Pradesh:** One Red Sand Boa Snake was seized and 03 persons were arrested by joint team of WCCB and U.P. State Forest & Police Dept. on 04-09-2021 from Moradabad.

**Tamil Nadu:** On intelligence of WCCB, five hunters were arrested and six killed Hares and hunting weapons were seized by Sivagangai Forest Division (TNFD), on 05-09-2021.

**Rajasthan:** A joint team of WCCB and Rajasthan Forest Dept. team, seized assorted Jewellery items made of elephant ivory and arrested 01 person from Jodhpur, on 08-09-2021

**Assam:** Joint operation of WCCB and Assam Forest Dept. led to seizure of a live Pangolin & arrest of 03 persons from Dhanubhanga, on 09-09-2021.

**West Bengal:** Joint team of WCCB and West Bengal Forest Dept. seized 21 live Parakeets and arrested one person from Kolkata, on 09-09-2021.

**Uttarakhand:** Joint team of WCCB & Uttarakhand Forest Dept. seized 01 Leopard Skin with 27 Teeth and 02 Bear Bile & arrested 02 persons at Pithoragarh, on 11-09-2021.

**Chhattisgarh:** Joint team of WCCB and Chhattisgarh Forest Dept. seized approx. 3.5 kg. of Indian Pangolin scales and arrested one person from Chhattisgarh, on 15-09-2021.

#### Indian officials burn rhino horns to stop illegal trade

Sept, 2021 — Indian officials burned about 2,500 old rhino horns on Wednesday to spread awareness of the need to protect the rare animal on World Rhino Day. Dozens of Hindu priests performed rituals and chanted prayers as the top Assam state



elected official, Himanta Biswa Sarma, lit the fire on a large platform in a sports stadium near the famed Kaziranga National Park. The horns, which had been stored for years, were from rhinos that died of natural causes at Kaziranga and other smaller habitats across Assam state and those confiscated from poachers.

Kaziranga is home to nearly 2,500 one-horned rhinos and is the world's largest habitat for the rare animal. Armed forest guards protect the rhinos, but poachers still manage to kill some of them. Rhino horns are sold by poachers in South Asia, China, Vietnam and some other countries because of a belief that they contain an aphrodisiac and medicinal properties. Sale of the horns is illegal in India. "Trading in rhino horns must stop and the claim of these horns having medicinal properties is false," Sarma said. Sarma decided to

burn the horns to create more awareness about the need to protect one-horned rhinos and end poaching, said M.K. Yadava, Assam's chief wildlife warden. The park is 250 kilometers (155 miles) east of Gauhati, the Assam state capital.

#### Joint operation with Nigeria Customs Service leads to three arrests, seizure of 7.1 tonnes of pangolin scales and 870 kg of ivory

August 2021: Acting on intelligence provided by the Wildlife Justice Commission, Nigeria Customs Service officers searched a residential address in Lagos on Wednesday 28 July, arresting three suspects and seizing 196 sacks containing 7,137 kg of pangolin scales, 4.6 kg of pangolin claws and 870.44 kg of ivory. All wildlife products were destined for export. This is the ninth largest seizure of pangolin scales since 2019. The arrested individuals are suspected of involvement in a well-known transnational criminal network operating in West Africa, linked to approximately 50% of all major pangolin scale seizures over the past three years.....

#### **Truck stopped with** almost 1000 smuggled reptiles aboard

Aug, 2021: The scale of wildlife trafficking in Cambodia was graphically illustrated again today when a Virak Buntham Company truck was stopped in Siem Reap province with 984 lizards inside. The incident happened yesterday along Street 67 at Balang commune, Prasat Bakong district, Siem Reap province. Acting on information received, Forestry Administration officials stopped the truck and found the unfortunate reptiles packed into ice containers. It appears that the reptiles have originated in Mondulkiri province and then were being transported via Siem Reap to Sihanoukville. Reptiles are used extensively in Chinese Traditional Medicine and there is speculation that these lizards were bound for the Chinese market, where they are used as a component for medicines to treat asthma, cancer, diabetes and erectile dysfunction, among other conditions.

#### **Operation WILDNET-IV by WCCB**

Sept, 2021: To encounter the menace of Cyber Wildlife Trafficking, WCCB launched "Operation WILDNET-IV" under its 'WILDNET' Operation Series. The operation started from 1st of July 2021 and continued till 30th Sept, 2021 throughout the country. During the operation period, WCCB and other Wildlife Enforcement Agencies worked towards detecting cases of cyber wildlife trafficking through cyber patrolling and taking appropriate action against the cyber wildlife traffickers in a focused manner.

The operation code named as "Operation WILDNET" was first envisaged by WCCB in May 2017, taking into consideration increasing threat of online wildlife trade across the country. The operation was aimed at dragging the attention of the enforcement agencies within the country to work towards countering the menace of the ever increasing illegal wildlife trade over digital landscape.

WCCB has also convened three coordination meetings with digital platforms such as Quikr, Google, Snapdeal, Indiamart, Amazon, and OLX to discuss issues related to cyber wildlife trafficking and reach a consensus on sharing of information that would help in curbing this menace.

Operation 'WILDNET-I' was undertaken by WCCB from 1st May to 30th June 2017 throughout the country. Total 48 cases of online sale of wildlife contrabands were detected. 08 persons were arrested and 05 cases were registered during the operation period. 'WILDNET-II' was conducted from 01st to 30th November, 2019 and resulted in the arrest of a dozen offenders and the initiation of 09 criminal cases. 25 cases of online sale were detected during this period. 'WILDNET-III' was initiated from 01 July to 30 Sep 2020, in which 27 species were seized and 26 cases were registered leading to arrest of 46 persons in total.

An array of wildlife species and contrabands were seized in all these operations, including Falcons, Pangolins, Rhino Horn, Coral, Antlers, Civet Cats, Parakeets, Elephant Teeth, Monitor Lizard, Sea Fan, Musk Pod, Starlet Corals, Trochus, Turtle, Lion Teeth, Shark, Elephant-hair bracelet, Red Sand Boa, Indian Soft-shelled Turtle, Indian Tent Turtle, Meat of Deer, Meat of Wild Boar, Parakeet, Muniya, Elephant ivory idol, and Snake, etc..

'Operation WILDNET' has also brought several accolades to WCCB. In Feb, 2021, WCCB received the prestigious 'Asia Environmental Enforcement Award 2020' from United Nations Environment Program (UNEP) in 'Innovation Category' for running operation 'WILDNET-II'. This was the second time it bagged this award as the agency has earlier received Asia Environmental Enforcement Award in 2018 also in the same category.

'Operation WILDNET' has been a big success so far and WCCB is committed to carry it further to eradicate ever-growing illegal wildlife trade on the digital platform. Data of recently held operation 'WILDNET-IV' is being compiled and would be made public soon.



#### Pangolin, tiger poachers held from Deolapar, Paoni

Nagpur: In a major crack-down against two gangs of wildlife criminals, the Maharashtra and Madhya Pradesh rashira and Madnya Pradesh forest departments, along with Wildlife Crime Control Bureau (WCCB), nabbed pangolin, ti-ger and herbivore poachers from Paoni and Deolapar.

According to sources, the body parts that were seized may belong to 2-3 tigers and at least 5 pangolins. The other material that has been seized include two bore guns, horns, peacock feathers etc.

"Paoni range forest officials

nabbed three persons from separate locations in the Paoni range and seized over 22kg pangolin scales from them," sa-id Bharat Singh Hada, deputy

conservator, Nagpur. Paoni RFO Ritesh Bhongade Paoni RFU Kitesh Bhongade said the accused have been iden-tified as Prashant Chachere and Dilip Admane, both from Kano-ra, and Ratanlal Madaye, Tangla. The accused have been remanled in two-day forest custody.

"The forest team seized 6.5kg pangolin scales from Cha-chere while 14.5kg scales were confiscated from the house of Milatram Bhalavi of Ramzang hoti. Bhalayi is absconding and the hunt for him is on," he said.

In the second incident, teams from WCCB, Central Region, Ja-balpur, Maharashtra, and MP forest department laid a trap near Khawasa border and nabbed one Balchand Warkade of Sita-pur in Ramtek. The teams seized a gunny bag from the accused in which tiger bones and horns of herbivores were found.

#### **Species of the Quarter**

# **Turtles**

(Scientific Name: Testudines)

-Key Facts-

Turtles are reptiles of the order Testudines, characterized by a special bony or cartilaginous shell developed from their ribs and acting as a shield.

Tortoise are distinguished from other turtles by being land-dwelling, while many (though not all) other turtle species are partly aquatic. It can reside inside freshwater or saltwater.

Turtles are cold-blooded species & have higher range of body temperature and move between environments to make themselves warmer or cooler.

They have very slow metabolism and can survive without food and water for a long time. Turtles live all over the world in almost every type of climate.

"Turtle," "tortoise" and "terrapin" are often used interchangeably as synonyms, but there are distinct differences between the types of chelonians.

The shell of a turtle is unique among vertebrates and serves to protect the animal and provide shelter from the elements. It is primarily made of bone.

There are five Marine Turtle species in Indian waters i.e. Olive Ridley, Green turtle, Loggerhead, Hawksbill, Leatherback, and several fresh water turtle species including Indian Flapshell Turtle, Indian Roofed Turtle, Indian Softshell Turtle, Red Crowned Roofed Turtle, Indian Tent Turtle, Black Pond Turtle, besides tortoise species of Indian Star Tortoise



#### Significance:

They are among the oldest and most primitive groups of reptiles, having evolved millions of years ago and play an important role in ocean ecosystems by maintaining healthy seagrass beds and coral reefs, providing key habitat for other marine life. It also helps to balance marine food webs and facilitate nutrient cycling from water to land. Thus, conservation of turtles will help to conserve biodiversity and to maintain natural balance.

#### **Turtle Conservation in India**

According to the International Union for Conservation of Nature (IUCN) most of the species of turtles & tortoises are vulnerable, endangered or critically endangered.

The Olive Ridley, Leatherback and Loggerhead are listed as 'Vulnerable' on the IUCN Red List of Threatened Species, while the Hawksbill turtle is listed as 'Critically Endangered' and Green Turtle as 'Endangered'.

Turtles are protected under Indian Wild Life (Protection) Act, 1972.

World Turtle Day is observed on 23 May to increase attention on conservation of Turtles and Tortoises.

**Threat:** Out of 300 species of turtles in the entire world, out of which 129 species are endangered. This is because of constant human interruptions in their natural habitat. They are also poached by humans and are pushed into illegal pet trade. The most common reason why they are endangered is because they are slaughtered for their meat, skin, shells and other properties. Rare species are seen as status symbols and collectors' items and are sold at high value.
