PLA.571/2010/6 : In pursuance of the provision of Section 6 of the Delhi Special Police Establishment Act, 1946 (Act 25 of 1946) the Governor of Assam is pleased to accord the consent of the extension of powers and jurisdiction of the members of the Delhi Special Police Establishment in the whole of the State of Assam for investigation of offences relating to carrying, supplying or trading or smuggling etc. of the bones, skulls or any other part of the body of animals or articles etc. derived from scheduled animals and arising out of the recent seizure of huge cache of wild life articles such as tiger bones & skulls and pangolin scales and punishable U/S 120(B) IPC R/W Sections 49, 49 (b) and Section 51 of the Wildlife (Protection) Act, 1972 and any other offence / offences, attempts, abetments and conspiracy in relation to or in connection with the above mentioned offence(s) and any other offence/offences committed in course of the same transaction or arising out of the same fact or facts and simultaneously launching of Criminal Prosecution against the guilty persons.



S.O. In exercise of the powers conferred by section 3 of the Delhi Special Police Establishment Act, 1946 (Act No. 25 of 1946), the Central Government hereby specifies the following offences to be investigated by the Delhi Special Police Establishment namely:

- (v) The Wild Life Protection (Assam amendment) Act, 2009
- (vi) The Wild Birds and Animals Protection Act, 1912 (Act No. 8 of 1912).
- (vii) Sections 109,115,166-A,166-B,171,174-A,195-A,228-A, 228-B, 229-A, 326-A, 326-B,354,354-A, 354-B, 354-C, 354-D,370, 370-A, 376, 376-A, 376-B, 376-C, 376-D, 376-E, 422 and 511 of the Indian Penal Code, 1860 (Act No. 45 of 1860) and

(b) Attempts, abetments and conspiracies in relation to or in connection with the above mentioned offences and any other offence or offences committed in course of the same transaction or arising out of the same facts.
