OFFICE MEMORANDUM

Clarification about policy circular on import of hunting trophies of exotic species. Sub:

1. Policy Circular No 3-42/2013/WL- I dated 25th of February 2014

2. Letter No. 3-2/2000 WL-I dated 4th July 2001

Vide reference 1 above, the Ministry has issued a detailed policy to regulate the import of hunting trophies of exotic species into India. Prior to that, an advisory was issued to all Chief Wildlife Wardens vide letter at reference 2 above stating that import of trophies and animal articles of look alike species will not be allowed.

The definition of "trophy" for the purpose of the policy circular needs to be understood in context and cannot include a commercial consignment traded regularly. The essence of the policy as well as the letter referred above has been to stop import of animal hunting trophies meant for display and also to ensure that the tendency of acquiring such animal trophies does not encourage the illegal activities of hunting and trade of wildlife. Either of them were never meant to prohibit or put in greater control over the import of products of animals not listed in Wildlife (Protection) Act, 1972 or CITES and meant for commercial use.

It has come to the notice that officer of WCCB located at border point are holding back the trade consignments of wildlife products, for which proper licenses are available and pretext for such action is said to be the policy circular referred at reference no. 1. Import of animal products is regulated under the EXIM policy and the DGFT seeks comments from the Ministry before issue of import licence. Once the import licence has been issued, the enforcement authorities need to verify that the imported products are in accordance with the import licence. Specific role of the WCCB/AMAs is to ensure that only the item which are permitted under the accompanying documents are coming into the country and not illegal material, like another material being smuggled in the name of legally permitted material or materials for which there is no documentary authorisation.

Further, for the sake of utmost clarity, it is stated that when a comprehensive policy circular vide reference 1 above has been issued, the reference2, which is only an advisory to the states not to recommend certain material for import, cannot override the policy.

POLICY CIRCULAR

Sub: Regulation of import of hunting trophies of exotic species into India -reg.

Noting that the Wild Life (Protection) Act, 1972 has been enacted by the Parliament to accord protection to wildlife and its habitat in the country;

Conscious that import of hunting trophies of exotic species, that are hunted outside India is regulated under the provisions of CITES and that there is a need to take holistic approach towards conservation of wildlife in the country in the context of requests for import of hunting trophies into India;

Realizing that the uninterrupted import of such trophies for display in private or public, except in educational institutions and museums serves no public interest, and at times, can even accentuate the tendency of acquiring those of Indian wild life, thereby indirectly encouraging the illegal activities of hunting and trade of wildlife.

Aware that difficulty in distinguishing hunting trophies of exotic species from the look-alike Indian species protected under the various schedules of Wild Life (Protection) Act, 1972 may camouflage the hunting of Indian wildlife and may also encourage killing of protected Indian species, rendering the enforcement of Wild Life (Protection) Act, 1972 difficult;

Recognizing the need of a regulatory policy for import of hunting trophies into India to enable the enforcement agencies to prevent the illegal hunting/poaching of the species protected under the Wild Life (Protection) Act, 1972 for trophy making;

Acknowledging that scientific institutes in the country have capacity of providing advice on look-alike exotic wild animal hunting trophies with reference to Indian fauna that are protected under the Wild Life (Protection) Act, 1972;

Also, acknowledging that it is expedient for the Ministry of Environment and Forests to prohibit import of all hunting trophies of exotic species into India that look-alike Indian fauna protected under the Wild Life (Protection) Act, 1972 and to restrict the import of exotic hunting trophies to the possible extent;

It is here by decided that the import of the hunting trophies of exotic species will be restricted as below:

a) No trophy will be permitted for import which is made from the species either listed in Appendix I of CITES, as amended from time to time as on date of receipt of application in the Ministry; or look-alike of any species protected under the Wild Life (Protection) Act, 1972;

b) The number of trophies for import from other species not indicated above shall be limited to 20 (twenty) for each applicant in a year starting 1st April and ending on 31st March of the following year. Applications of only those individuals will be considered who themselves have legally hunted those animals in foreign countries in respect of which import permission is being sought.

The Ministry shall endeavor to display on its website a list of animals often hunted in foreign countries for trophy making along with corresponding look alike Indian fauna protected under the Wild Life (Protection) Act, 1972 coming within the purview of a) above, and also to update the same from time to time.
