ADVISORY

In order to deal effectively with the organised criminals involved in illegal wildlife trade networks with trans boundary linkages & international ramifications, it would be necessary to establish the links along the chain and deduce strong evidence in establishing the same. For the purpose, it would be necessary to record details pertaining to the criminals, so as to facilitate cross checking their involvement in future. It is therefore necessary to record all the personal information for generating the profile of the wildlife criminals and to keep their movement under watch.

It is requested that when a wildlife criminal is apprehended by the forest or police department, the Investigation Officer may be directed to record the details of such criminal on the format enclosed. Therefore, it would be appropriate to issue necessary instructions to all the field staff, in order to systematise the above practice.

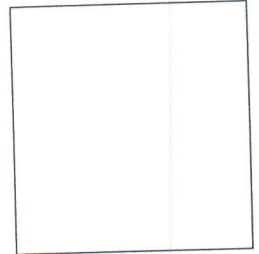
