VACANCY CIRCULAR

SUB: - Filling up of vacant post in Wildlife Crime Control Bureau - reg.

The Wildlife Crime Control Bureau (WCCB) is a multidisciplinary statutory body constituted under the Wild Life Protection Act, 1972, for combating organized wildlife crime in the country. The Bureau HQ is located in New Delhi and it has five Regional Offices (New Delhi, Mumbai, Jabalpur, Chennai, Kolkata), three Sub Regional Offices (Amritsar, Cochin, Guwahati) and five Border Units (Gorakhpur, Motihari, Nathula, Moreh, Ramanathpuram). The posts sanctioned in the Bureau are to be filled by the officers on deputation.

 - iii. Vigilance Clearance Certificate and Integrity Certificate duly issued by the competent authority in original
 - iv. Major / Minor Penalty statement for past 10 years duly issued by the competent authority in original.
