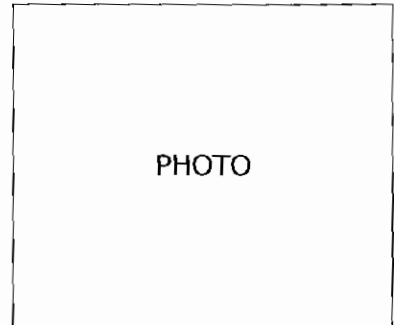

I also understand and agree that holding of this position does not entitle me to undertake any law enforcement actions directly. I have to pass the information received to the relevant mandated enforcement agencies which, in turn, will conduct the raids, check premises or undertake any other relevant legal or enforcement actions as required. I will be assisting officers empowered under law to take legal actions.
4. I will render my services as Volunteer at my own risk and cost.

I will keep the Identity Card, if issued to me, under my control and custody and shall immediately report the loss or damage thereto, if any, to nearest police station and also office of the Additional Director, WCCB by speed post/fax/telephone. I also understand that the WCCB may refuse to issue duplicate Identity Card and also to renew my tenure.
6. I will surrender the Identity Card, if issued to me, whenever demanded by the Additional Director, WCCB or Regional Deputy Director, WCCB having jurisdiction over area of my address given in this application.
